- (i) Three (03) Seater Sofa set 03 Pieces (Type of wood Teak wood, Approx. Size: L- 78" x H- 28" D 33") (ii) Two (02) Seater Sofa set – 03 pieces (Type of Wood – Teak wood, Approx. Size: L-57" X H – 28" D – 33") (iii) One (01) Seater Sofa set – 03 pieces (Type of Wood – Teak Wood, Approx. Size: L-57" X H – 28" D – 33")
